

ERICEIRA CAMPING REGULATIONS

This regulation contains the rules concerning **Ericeira Camping** - Mil Regos Camping Park use and functioning. Thus, besides the legal and lawful binding dispositions, specifically applicable, this Intern Regulation rules and the ones established on the commercial agreements made with the users will be applicable in the same way.

CHAPTER I FUNCTIONING PERIOD

1st Article – Functioning

The Camping Park is functioning twenty four hours all year long, except during the period or periods when it has to close, in the terms of the 3rd article of this regulation.

2nd Article – Reception and Stillness Period

1. The Camping Park reception and the services it provides function all year long, between nine a.m. and eight p.m..
2. The Park's access and exit which do not depend on the reception functioning, namely because the users have an automatic access card, may be carried out at any time of day or night, without damage to the stillness period rules, being this the case.
3. The stillness period occurs between eleven p.m. and next day's eight a.m..
4. During the stillness period it is strictly forbidden to produce any type of noise such as using sound devices and instruments, talking out loud and moving around in the park using any kind of motor vehicle.
5. The Reception's Functioning period may be altered by GIATUL, E.M. decision, in which case this alteration will be posted in the reception 8 days ahead of time.

3rd Article – Closing and Suspending Functioning

1. The Camping Park may close, total or partially, during a determined period or periods, the motive being repairs, cleaning or other by which it becomes necessary to close.
2. The Camping Park may, in the same way, close or suspend the respective functioning by order of any public authority.
3. In case the closing of the park may be determined beforehand, GIATUL, E.M. will, in advance, inform the users by posting warnings in suitable places of the Park.
4. On the rest of the cases, GIATUL, E.M., will inform the users as soon as the action or fact which forces the closing of the Park is known.
5. The users must clear all of their equipment from the Camping Park at notice indicated on the warnings, under penalty of removal by GIATUL, E.M. at the users account and risk, which will be equally responsible for the payment of the damages caused.

CHAPTER II ADMISSION AND REGISTRY CONDITIONS

4th Article – Admission

1. The Camping Park may be used by national and foreign users bearers of one of the following documents, rightly updated:
 - a) Identity Card or Passport;
 - b) National or International Camper Card;
2. Whenever the user or visitor does not have any of the documents referred in the previous number, other document or identification must be presented, on a valid period, whose sufficiency will be decided by GIATUL, E.M.
3. Campers under 15 years old may only use the Camping Park when accompanied by their parents,

legal representatives or adults held responsible for them.

4. The entry and staying of visitors is prescribed on the 10th article of this Regulation.
5. The users and visitors must identify themselves whenever asked by GIATUL, E.M. representatives, or by any authorities, in the Park or in a place directly or indirectly exploited by it.

5th Article – Refusal of Admission

1. GIATUL, E.M. may refuse access and lodging to a number of users superior to its capacity.
2. It may, in an equal manner, refuse access or permanence to whom disturbs its regular functioning, namely for:
 - a) Incorrect use of the services offered by the Park;
 - b) Refusing to comply by the rules of this regulation;
 - c) Improperly lodging other people;
 - d) Entering service areas or others of restricted access;
 - e) Being accompanied by animals on restricted places or periods of time.

6th Article – Registry

1. In the act of the user admission, the entry will be registered with the name and identification elements of both you and the people that come with you, the specification and checking of all the material that constitutes your equipment and the indication of how long you intend to stay.
2. Without prejudice of what is stated in the 3rd article, GIATUL, E.M. only assures the stay of the user and the people that come with him in the Camping Park, for the indicated staying period in the act of admission.
3. The admitted and registered user will be handed out a card and an equipment "label" which must

- compulsorily be placed on the outside part of it, on a visible spot.
4. If the user decides to alter some of the data or elements in the admission registry, he must submit this alteration to GIATUL, E.M. which will decide in the terms of this Regulation and, in case the stay is altered, according to the installations available and assumed compromises.
 5. Along with the user's admission registry, copies of the documents presented on the 1st and 2nd numbers of the 4th article in this Regulation will be filed.
 6. In the end of the stay the user must hand back the cards and labels given to him and all Camping Park objects that have been delivered to him, under penalty of being considered illegitimate bearers, with its legal consequences and having to pay GIATUL, E.M. respective damages.

CHAPTER III USER'S RIGHTS AND DUTIES

7th Article – Rights

The users have the following rights:

- a) Using and enjoying the Park's equipment and services according to this Regulation terms and bearing in mind all of the legislation and applicable regulations;
- b) To be given copies of the legal and regulating rules, invoked by GIATUL, E.M.
- c) To be presented with the Claim book to use that right when required.

8th Article – Duties

1. The users have the following duties:
 - a) To fulfil this Internal Regulation dispositions and all the rules, namely the technical ones that are a

- part of it, as well as all of the legal and regulating dispositions applicable.
- b) To respect, inside the Camping Park and the areas under GIATUL, E.M. jurisdiction, the authority of the ones responsible for it.
 - c) To provide these people in charge documents and identification elements whenever asked.
 - d) To accomplish the Camping Park adopted and established hygiene principles, specially the ones referring to litter destination, wastes and dirty waters, washing and cleaning clothes, animal's maintenance and the ones respecting the prevention of contagious diseases.
 - e) To install and keep your camping space and equipment according to the Park rules and in a good state of conservation, hygiene and cleanliness.
 - f) Do not alter your equipment's characteristics and outside look without being previously authorised by GIATUL, E.M.
 - g) To refrain any acts that may bother other campers, namely propaganda, whatever its nature, and making noise, specially on the stillness period, according to the terms expressed in number 4 of the 2nd article in this Regulation.
 - h) Do not lit fire, except when using equipment to cook meals, according to authorised terms, using all precautions and following all rules of safety against fire hazard.
 - i) Do not bring in or allow the entrance of people foreign to the Park without following the rules applicable to visitors.
 - j) To obey the Park's road-signs and GIATUL, E.M. indications in what concerns circulation and parking of vehicles.
 - k) To install your equipment on the place destined for you and not in any other place according to GIATUL, E.M. instructions.
 - l) To pay without delay the stay in the park, amounts consumed and services used according to the price-list;

- m) Do not restrict any zone inside or outside the area destined for you to camp beyond your instalments.
 - n) To leave the Camping Park, with all your equipment and possessions, in the end of the period established according to the 3rd article of the Regulation.
 - o) Do not practise any of the forbidden acts designated on the following article.
 - p) To pay respect to the rules of conduct and social contacts, according to the laws of good citizenship.
 - q) Do not cause any damage in the Park, or in any of its accommodations, even if it is a concession, or on a user or other people's possessions.
 - r) Do not use, own, trade or consume any substance qualified as narcotic.
2. When users, visitors and other people disrespect, in general, the Internal Regulation rules and, in particular, violate the obligations stated on the previous number, and the ones registered on contract, their staying in the Camping Park may be refused.
3. When someone is not allowed to stay in the Park, according to the previous number, that may mean future refusal of admission, as long as it is duly justified.

9th Article – Disallowed

It is completely forbidden:

- a) To practise any kind of act such as wearing clothes or using terms that may offend morality or the Park order.
- b) To destroy or molest trees, plants and such.
- c) To go over or destroy the fences that exists on the Park.
- d) To use material that goes against camper's ethics, to cover the soil not allowing airing, perviousness, or to build limitations or decorations on their camping site with inappropriate materials, such as: boxes, wood,

- bricks, plastic, canvas, gates, wires, vases, climbing plants arches, etc..
- e) To place cables for drying clothes or wires whatever the material at a 2 metres inferior height or wires at any height.
 - f) To throw debris, rubbish or waste out of the dustbin or out of the place destined for such a purpose.
 - g) To use the drinking fountains to get rid of waste or as a dish-washer.
 - h) To connect hoses to the Parks water system.
 - i) To open a ditch or spill water with any kind of debris on the land.
 - j) To let the water that comes from trailers or recreational vehicles sewers go into the soil, it is compulsory to use an adequate receptacle.
 - k) To wash sheets, blankets, quilts, clothes that are not of personal use and clothes not used in the Park.
 - l) To leave the tap open, to waste in any way or to damage the piping or other structures.
 - m) To use guns of any kind.
 - n) To play games or sports outside the suitable premises.
 - o) To install the camping equipment and its extras at an inferior distance of one metre between the different elements, this distance must be of two metres with regard to other user's equipment.
 - p) To use coverings on camping equipment, except when respecting paragraph a) to e), number 3, 7th article of the 14th lawful decree of 12th of March 2002, not being allowed to go over 10 centimetres a unit by protecting any of the sides or superior boundaries, which requires the previous presentation of project to be approved.
 - q) To live in the Park permanently.
 - r) To leave randomly abandoned during the night: lamps, stoves, lighted electric torches because of the danger it represents.
 - s) To post any writing or drawing without GIATUL, E.M. authorisation.
 - t) To keep sleeping bags, blankets, etc., stretched outside tents or trailers, after 11 a.m.

10th Article – Visitors

1. Visitors of the Park users may be authorised, including family members, when introduced by the users and under their entire responsibility.
2. The visitor's entry may only take place during the reception's functioning period and their stay is limited to one hour, under penalty of paying an amount posted on the reception.
3. Visitors may not use their vehicle inside the Park, except deficient persons.
4. The entry and staying authorisation for visitors may be limited, revoked or refused by an expressed and founded decision by GIATUL, E.M.

11th Article – Permanency and Circulation of Vehicles and Bicycles

1. The user has the right to park one vehicle on the Park's duly indicated and identified fittings, as long as he asks for it in the act of admission and registry.
2. GIATUL, E.M. will not be responsible for these vehicles safety, declining any responsibility for eventual accidents, damages, theft of both the vehicle and objects found in its interior.
3. The circulation of vehicles is only allowed for loading, unloading, company or priority vehicles, when entering or leaving the Park and in cases authorised by GIATUL, E.M..
4. It is not allowed to do any kind of repairs, tunings, washings or leaving the alarms on in the Park.
5. In case the vehicle may circle in the Park, you must not sound the horn or go over ten kilometres or six miles an hour.
6. The parking of a vehicle outside the marked areas, gives GIATUL, E.M. the right to tow it at the user's expense in case it is not immediately and voluntarily removed by its owner.
7. The same will be done towards any vehicle without any authorisation or infracting the rules of this regulation.

8. The Park's parking may be limited or interdicted, whenever GIATUL, E.M. thinks it necessary and, specially, for security reasons.
9. The vehicles registered in the reception which arrive the Park during the stillness period must be parked on a different place from the one previously designated. The amount initially established must still be paid.
10. These rules, duly adapted, are also applied to the circulation of bicycles; however, this circulation is forbidden from sunset to sunrise.

12th Article – Pet Authorisation and Admission

1. It is allowed the admission of healthy pets that accompany the user and are registered at the entry of the Park.
2. Pets must use a leash near the user's equipment, in such a way it must not wonder off for more than two metres and never bother the rest of the users.
3. The entry of pets into Park buildings such as the Meeting-Hall, Reception, Offices, Bungalows, Tepees, Bathing-Places, Coffee-House – Pizzeria, Mini-Market, Pools or any other place not specified here is strictly forbidden.

13th Article – Delay or Lack of Payment

1. The user's stay payment, amount, term and payment place are the ones indicated and posted in the reception by GIATUL, E.M.
2. The price of hired consumption, the way of payment and its term will also be posted on the Parks reception.
3. GIATUL, E. M. may alter the stay and service prices, in any occasion, as long as it is made public at least 60 days before.
4. The lack of punctual payment of overdue stay and extras compels the payment of debt, enlarged of a twenty per cent penalty if the delay is up to thirty days, and fifty per cent if the delay is superior.

5. The non-payment of three instalments, when such has been determined, will be seen as a refusal to stay in the Park from the user's part and will be carried into effect.
6. The lack of punctual consumption payment may determine the immediate supply's interruption.
7. Users will have to make up for loss to GIATUL, E.M. for the damages caused, including all legal expenses.
8. While the amounts in debt by the users are not entirely paid to GIATUL, E.M., all of the equipment, vehicles and the rest of goods remaining in the Park will be detained according to the 754th article of the Portuguese Civilian Code, not being the Park held responsible for its deterioration.
9. GIATUL, E.M. has the right to remove all detained goods, at the user's account, if he does not within the indicated term.
10. Detention right may be substituted by a suitable guarantee with the same value as the debt and other amounts predictably owed.

CHAPTER IV
OTHER ARRANGEMENTS

14th Article – Utilisation Clauses

1. The Park is divided into identified spaces whose use must be respected by the user and according to the instructions given by the reception.
2. The water, gas and electricity supplies (according to the typology) will be reckoned by the Park services and debited into the user's account who will pay the amount consumed only.
3. Whenever the user wants to check the counting of the amounts consumed, he must ask for it to the Park Services.
4. All abandoned or badly kept material will be removed by the Park services. The material will be considered abandoned when it's not identified or is found outside the proper space area.

5. The material will be kept on the Park's yard for 60 days, at the end of which the Park's responsibility ends.
6. The user will have his material back after proving it is his and paying all debts to GIATUL, E.M.

15th Article – Camping Material

1. It is not allowed the setting on the designated camping area even if the space allows it, of more than a unit and a kitchen (ex. trailer + 2,50 metres advanced + 1,80 metres).
2. The kitchen should not be more than a 1,00 metre apart from the unit.
3. Structures and coverings need a previous authorisation by GIATUL, E.M. through a suitable form according to the rules defined on the Portuguese Republic Diary 14/2002 and will only be authorised between the 1st of October and the 30th of May.
4. Laterals or Protections are allowed between the 1st of November and the 30th of April.
5. It is allowed the creation of artificial shadows as long as it is a material reactive to fire class M2 or inferior, with a maximum measure of nine square metres whenever the user is present. They must be withdrawn in the user's absence.
6. It is allowed the placing of wind-stoppers whenever the user is present. They must be withdrawn in the user's absence.
7. In the areas destined to Mobile Homes it is allowed the placing of pavement made of material reactive to fire class M0 (ex. squares of anti-side slipping rock with 30x30 centimetres or 12x12 inches), with 3 centimetres or 1 inch apart between them.

16th Article – Sanitary Facilities

1. Sanitary blocks must be used bearing in mind due respect for other users, hygiene and civic rules essential on this kind of lodgings and the saving of water and energy.

2. All facilities including sanitary blocks, dish-washers, clothes-washers or laundries (in case there is), must be left clean and in perfect hygiene conditions after used.

17th Article – Playground

1. The use of the playground equipment is not allowed to users above 12 years old.
2. The Park declines any kind of responsibility in case accidents not directly caused by deficiencies on the installed equipment may occur.

18th Article – Electric Power

1. It is only allowed one feed per unit from the contact box, not being allowed the connection of a unit from other one.
2. It is only allowed to use confirmed and in perfect state of conservation and functioning connecting material.
3. It is forbidden to suspend electric cables on trees or bushes and in any place it may affect the Parks aesthetics or its user's safety.
4. Feeding cable repairs are not allowed whatever the reason.
5. The number of installations in each box must not be superior to the number of existing plugs.
6. The connection of a unit may be refused when it's not in proper conditions.
7. In case the units are not occupied, GIATUL, E. M. may cut the power off, in which case the damages, such as the deterioration of perishables may not be attributable to the Park.
8. Besides the original electric installation, a spot of light in the equipment to illuminate the headway is allowed.
9. It is only allowed the use of electric energy on the kitchen as long as you use a watertight electrical extension with a plug and a lamp and when its use is justifiable.

19th Article – Technical Rules

1. The technical rules respecting the use of structures, coverings, advancements and coatings, constituting Annex I, are part of this regulation.

20th Article – Responsibility

GIATUL, E.M. declines any responsibility on accidents, damages, thefts or stealing of campers or its material. Responsibility for these actions must always be attributed to its authors or tutors in case of handling with minors.

This Regulation, approved on this day by GIATUL, E.M. Board of Administration, substitutes the previous one and comes into force immediately.

Cases excluded from this Regulation will be solved by GIATUL, E.M. Administration.
